- Up to 5,000 tickets may be sold for this raffle.

- \$50,000 or 40% of proceeds (GRAND PRIZE)

Raffle Rules and Regulations

- 1. All ticket purchasers must be 18 years of age to participate and provide proof of age prior to receiving any raffle prize.
